

# NZSIA Ski Ski Teaching in a Second Language ISIA Assessment Outline 2015

The Ski Teaching in a Second Language is a one-hour on snow assessment and is open to all Certified Instructors who are Full or Associate members of the NZSIA. This Assessment is a requirement of the ISIA stamp

#### Goal:

To assess the ability of the Candidate to teach an effective beginner lesson in a language other than English.

#### **Assessment:**

A basic Level of language proficiency is required.

Candidate will be assessed in the following areas: vocabulary, grammar, pronunciation as well as understanding and volunteering information.

The lesson will be presented using NZSIA technique and methodology

The Lesson follow the NZSIA teaching model including safety aspects of teaching

#### **Process**

- The Assessor will start the process with an introductory general conversation. The candidate will be able to answer questions relating to their name, age, where they live, and how long they have taught skiing.
- The Candidate will then present a beginner lesson, with a starting point chosen by the candidate, for approximately 15 minutes in the chosen second language
- The Assessor will ask the Candidate to make a mock call to the Ski Patrol and inform them of an injured guest including explaining where the injured guest is located and the general nature of the injury.

## **Procedure:**

NZSIA Ski can assess in the following Second Language's:

- French
- German
- Italian
- Japanese
- Korean

Arranging Assessment in other languages may be possible on request.
